Julie Marsland replaced Sue Highton as the Staffside appointed governor and Dave Swindlehurst replaced Janet Sullivan as the appointed governor representative Sheffield Mencap. Julian Payne, who had represented service users for the last three years, came to the end of his term on 31 August.

Governor Elections

Elections for two service user governors took place in August. The successful candidates were declared on 28 August and they were Rebecca Lawlor and Nev Wheeler OBE.
