Non Executive Director Activity

All Non Executive Directors remain active in chairing and managing the Board Sub Committees for which they are responsible. This includes agreeing and setting agendas, ensuring effective conduct of meetings, follow up of agreed actions and timely reporting.

Council of Governors (CoG)

The Council has met on one occasion since my last report and that was on the 25 February 2021.

The CoG continued its revised format starting with a Governor Story – on this occasion Scott Weich talked about "The role of appointed governors: A university perspective".

CoG Development

The next stage of CoG Development was discussed and agreed. Next stages included:

- Nominating a Deputy Lead Governor
- Establishing a rota of CoG members who would periodically observe board committees and clinical/departmental Board visits. The role and function of these observers would be clearly agreed.
- Further Governor training workshops would be arranged on engagement.

- Establish Governor lived experience stories at council meetings.
- Prof Brendan Stone Associate Non Executive Director and lead for User Experience and Engagement along with Salli Midgley, Director of Quality would work with the CoG to refresh service user engagement and its relationship with the proposed new Lived Experience Group.

Governor Elections

Governors terms of office stand at 3 years with up to three consecutive terms being allowable after which governors must stand down. Elections take place each year to appoint to existing vacancies or to seats where the terms of office have come to an end.

In 2021 there will be 12 seats available for elected governors and 2 seats for appointed governors 14 seats in total as follows:
