Background

To be considered for an award, eligible doctors must demonstrate achievements in developing and delivering high-quality patient care and commitment to the continuous improvement of the NHS.'

Under this guidance we are required to produce an annual report, to be shared with the Trust Board and Joint Local Negotiating Committee (JLNC). After consideration by the Board and the JLNC, the report content will be available on the trust website.
