The purpose of this report is to summarise the key areas of activity that the Chairman and Non Executive Directors have been engaged in and to highlight any relevant issues to the Board.

#### **SHSC Board Issues**

#### **Non Executive Director Recruitment**

Following open competition I am pleased to be able to report that the Council of Governors has endorsed the appointment of Dr Olayinka Fadahunsi- Oluwole as a Non Executor Director. Dr Yinka as she will be known is a Specialty Doctor in Community Paediatrics and Neurodisability working at Sheffield Children's Hospital. It is anticipated that Dr Yinka will join us at the beginning of June and once all normal employment processes have been completed we will be making a more formal announcement about her appointment.

I am confident that Dr Yinka will make a valuable contribution to the board and will bring a new dimension to our discussions. As a clinician she will also bridge a skills gap that we identified as part of our Board development.

I am looking forward to introducing Dr Yinka to the organisation and to working with her.

# **Chair and Non Executive Director Annual Appraisals**

The process of annual appraisals for the Chair and Non Executive Directors has commenced. The appraisal process is conducted in line with National Guidance. The Lead and Deputy Lead Governors join me as Chair for the NED Appraisal and join the Senior Independent Director for the conduct of the Chairs appraisal. The outcome of the appraisal process will be discussed at a forthcoming Nominations and Remuneration Committee and a report presented to the Council of Governors in due course.

## **Board Sub Committee – Mental Health Legislation Committee**

The new Mental Health Legislation Committee met for the first time on the 13 April 2021 following the review of our Board and Sub Committee governance arrangements. I currently Chair this committee but once we have a full compliment of Non Executive Directors we will review these arrangements.

### Wider System Working

Following the publication of the White Paper which proposes to strengthen the architecture of partnership working between Health, Local Authorities and wider system partners, work is moving at pace to agree new arrangements at both a SY&B level and at "Place" here in Sheffield to prepare for the changes that will become law in April 2022.

The new arrangements will give a statutory role to the current South Yorkshire and Bassetlaw Integrated Care System (ICS) and require new arrangements for partnership working and delegation of functions to the five places that make up SY&B (Sheffield, Barnsley, Doncaster, Rotherham and Bassetlaw). CCGs will be abolished and their commissioning functions transferred to the ICSs.

Both Jan and I are members of the Sheffield Accountable Care Partnership (ACP) and a Working Group that is tasked with designing the new arrangements here in Sheffield.

The Board has already had an opportunity of a briefing on these issues and I will continue to keep the Board updated on the progress of this important work. I am also arranging appropriate briefings for the Council of Governors.

## **Non Executive Director Activity**

During the last two months, all Non Executive Directors have continued to chair and manage the Board Sub Committees for which they are responsible. This has including continuing to develop the governance and reporting of their committees.

NEDs have continued to undertake internal discussions and participation. These has included participating in:

- Staff Network Groups
- Discussions with key leads within the Trust about areas of interest (Equality and Diversity, Programme Management office, Freedom to speak up Guardian, Staff side)

NEDs undertook further mandatory training, and all Board members are now up to date.

## Council of Governors (COG)

#### **Council of Governors Development**

The development programme for the Council continues. A Clinical and Social Care Strategy Workshop was held on the 11 March and further workshops are planned as follows:

- Engagement Workshop 2 June 2021
- Integrated Care Systems/Accountable Care Partnerships (ICS/ACP) 29 June 2021

There will be a further discussion at the Council meeting on the 15 June to plan the next phase of the development programme.

#### **Deputy Lead Governor**

Following request for nominations for the Deputy Lead Governor role I am pleased to be able to report that Ben Duke (Public Governor) has been elected to this role.

#### **Governor Elections:**

Governor Elections are underway and the deadline for nominations is 14th May 2021.

Appointed governors have been confirmed as follows:

- Prof Scott Weich has been confirmed as representative of Sheffield University and is serving his second term effective immediately.
- Celia Jackson-Chambers has replaced Fay Colphon as appointed governor for SACMHA effective from 1<sup>st</sup> May 2021.

#### **Wider Involvement of Council Members**
