Summary of key points in report

The term of office for Governors is three years, with up to three consecutive terms being allowable after which governors must stand down.

Each year elections take place to appoint to existing vacancies or to seats where the terms of office has come to an end.

This summary report provides an update on Governor Elections currently underway for 2022 and recommended next steps for discussion and agreement.

Of the 24 vacancies, 16 remain with only one seat to be contested (Rest of England Constituency) and the remainder to be appointed un-opposed. All newly appointed Governors will be formally received and appointed at the June Council of Governors meeting following successful completion and receipt of Fit and Proper Person's test. DBS and Declarations of Interest.

The Lead Governor role will be up for election at the June meeting. The current Lead Governor was extended in the role in December 2021 to allow for the election process to take place and will be entitled to stand for election again if they so wish.

It is recommended that work take place to plan for a potential by-election to address ongoing vacancies and that the review of the Constitution be brought forward.

Governor Elections Update

Section 1: Analysis and supporting detail

Background

The term of office for Governors is three years, with up to three consecutive terms being allowable after which governors must stand down. Each year elections take place to appoint to existing vacancies or to seats where the terms of office has come to an end.

In 2022, 24 seats will become vacant as follows:

Next Steps

All successfully appointed Governors will need to complete Fit and Proper Person's test, DBS and Declarations of Interest before they are finally confirmed in post at the June meeting.

As the Lead Governor was up for re-election as a Governor we will also need to hold election for the Lead Governor role in June, for which the current Lead Governor is entitled to re-stand if they wish to do so (their current term was extended from December to June to allow for the elections to take place).

The Chair, Lead Governor and Director of Corporate governance will need to discuss and recommend timing for holding a by-election particularly in respect of staff governor seats. Discussion will also take place at the Executive Team with regard to communication and awareness raising of these roles.

The Constitution was last reviewed and approved in December 2019. We were already planning a review of the Constitution to ensure it reflects the current organisational structure in terms of the classes outlined and to consider the size of the Council of Governors given the size of the organisation. In light of the disappointing response to the current election process the Chair and the Director of Corporate Governance have discussed and are recommending the planned review of the Constitution be brought forward with the updated document received at the Council of Governors for final approval in the autumn of 2022.

Recommendation

The Council of Governors is asked to note the update provided and to discuss and agree to the recommended next steps.
