#### Summary of key points in report

The term of office for Governors is three years, with up to three consecutive terms being allowable after which governors must stand down.

Each year elections take place to appoint to existing vacancies or to seats where the terms of office has come to an end.

This summary report provides an update on Governor Elections for 2022 and recommended next steps for discussion and agreement.

Of the 24 vacancies, 8 vacant seats have been filled and the details of elected governors are detailed in the this report. 16 vacancies remain. It was agreed at the last Council of Governors meeting to bring the review of the section of the Constitution relevant to quoracy forward to support the Council to remain quorate whilst recruitment takes place to remaining vacant seats. This will also need to include a review of the appointed seats section given pending changes with CCGs.

A slide update will be provided on this at the meeting by the Director of Corporate Governance with the changes then agreed via e-governance post meeting, if required, and then taken to the Board for ratification in July.

All newly appointed Governors will be formally received at this June Council of Governors in advance of formally starting in role from 1 July 2022. Commencement is dependent upon successful completion and receipt of Fit and Proper Person's test and Declarations of Interest, and it is understood may need to begin whilst DBS checks remain ongoing.

The Chair, Director of Corporate Governance and Lead Governor will discuss next steps in terms of timing for recruitment to the vacant roles.

## Section 1: Analysis and supporting detail

#### Background

The term of office for Governors is three years, with up to three consecutive terms being allowable after which governors must stand down. Each year elections take place to appoint to existing vacancies or to seats where the terms of office has come to an end.

Nominations were received in line with the plan and published on 14 April 2022 by UK Engage. Only 1 seat, which is for the Rest of England constituency, was contested; all other seats were elected unopposed subject to successful completion of the Fit and Proper Persons test, DBS and Declarations of Interest. Ballots for the contested seat closed on 26 May following which results were published – **see appendix A**

Declarations of Interest and Code of Conduct forms have been issued for completion and are required to have been received by the June Council of Governors in order for the Declaration of Interest table to be updated and shared on the website. Those received by the time of the meeting are presented in a separate report. Colleagues are requested to ensure completed forms are received by the end of June. If they have not been received in full at the June meeting a further update will be provided to the next Council of Governors meeting.

#### **Next Steps**

All successfully appointed Governors will need to complete Fit and Proper Person's test, DBS and Declarations of Interest before they are finally confirmed in post.

The Chair, Lead Governor and Director of Corporate governance will need to discuss and recommend timing for holding a by-election particularly in respect of staff governor seats. Discussion will also take place at the Executive Team regarding communication and awareness raising of these roles.

The Constitution was last reviewed and approved in December 2019, an interim update is taking place as outlined and as agreed previously a full review of the document will take place across the summer for receipt at the Council of Governors in the autumn.

#### Recommendation

The Council of Governors is asked to note the update provided and to discuss and agree to the recommended next steps.

Approve changes to the Constitution (provided as a separate item) with implementation of these subject to ratification at the Board.
