- Given the broad ways in which Governors are able to engage between formal meetings of the Governors outlined on the calendar, for example with additional sessions in place around Quality, Finances and Engagement consideration is being given to the number of formal meetings required across the year and views on this from colleagues would be welcome.
- Generally speaking Councils of Governors will meet formally 4 5 times across the financial year including the Annual Members Meeting which Governors are encouraged to attend.
- Annual Operational Plan and Priorities will be received at CoG in April a refreshed list of priorities, following receipt of national policy and guidance will be brought back to the Council of Governors, so propose mid-year review to CoG in October as will not be a December meeting.
- QAC Chair of Committee presentation has been moved to October (as there is currently no December meeting)
- Salli Midgley, the Executive Director of Nursing and Professions has confirmed the next review of quality objectives will be in 2027, time for consultation will need to be factored into the work programme that year.
- A session in interpreting SPC charts will be organised for interested governors as a development workshop led by Performance and Analytics Manager with support from the Executive lead timing confirmed for 2 July 2024.
- A dedicated session to outline to governors work taking place on recruitment and health and wellbeing led by the Chair of People Committee with support from the Executive Lead, and linking in with the staff governors and the health and Wellbeing NED Champion –timing confirmed for 2 July 2024.
- A session to provide governors with an update on the financial situation, led by the Chair of Finance and Performance Committee and the Executive Director of Finance timings confirmed for 20 May 2024 with Chair of Finance and Performance Committee and the Executive Lead. FPC Chair of Committee presentation will be covered in this session.
